## From the Editorial Board of the Scientific Journal "Vestnik Permskogo Universiteta. Seriya "Ekonomika" ("Perm University Herald. ECONOMY").

An author grants the journal's Publisher (Perm State University) the right to use their article as part of the journal, as well as to add full-text versions of the article to the "Russian Science Citation Index" (RSCI) system.

The right to use the journal as a whole belongs to the Publisher in accordance with paragraph 7, Art. 1260 of the Civil Code of the Russian Federation and is valid indefinitely in the territory of the Russian Federation and abroad.

The Publisher's scope of rights to use the journal as a whole corresponds to the scope of the author's exclusive right provided by Art. 1270 of the Civil Code, the Publisher may also allow others to use the entire Periodical on certain conditions at the Publisher's discretion.

There is no remuneration to the author for granting the above rights to the Publisher.

The author of an article published in the journal preserves the exclusive right to the article, irrespective of the Publisher's right to use the journal as a whole.

Submission of an article to the journal means the author's consent for the article to be used by the Publisher on the above conditions and added to the RSCI system as well as indicates that the author is aware of the terms of use of the article. Submitting background information about the author to the editorial office (including by e-mail) is also seen as this kind of consent.

The editorial board places full-text versions of articles on the Perm State University website (http://www.econom.psu.ru) and adds them to the «Russian Science Citation Index» (RSCI). Submission of an article to the editorial office means the author's consent to the above-mentioned placement and addition.

There is no author's fee for publication. An author's copy will be sent to the specified address.

## Publication of manuscripts is not charged.

The editorial board informs that articles for the journal are accepted in the Russian and English languages, their size should be not less than 0.5 printer's sheet (20,000 characters) and not more than 1 printer's sheet (40,000 characters), they should be sent in printed (one copy) and electronic versions and formatted according to the requirements of the editorial board. Articles received by the editorial board will not be returned.

## Mandatory requirements for manuscripts

- 1. All manuscripts should be submitted in both electronic form (articles prepared in MS WORD format should be sent by e-mail) and printed form (one copy printed on A4 sheets). Settings: margins 2 cm; font Times New Roman; font size 14 pt; spacing single. Tables and figures are placed in the main text and should have appropriate titles; font size for tables 12 pt, spacing single; font size for captions 12 pt; all figures should be black and white; table borders should not be thick.
- 2. The number of authors per paper must not exceed three.
- 3. The printed copy of the article must be signed on the last page by all the authors, a scanned copy of this sheet should be sent to the editorial office by e-mail.
- 4. The author's(s') name(s), their academic degree and title, place of employment, position, address and e-mail should be specified at the beginning of the article.
- 5. Each article must be supplied with an abstract. The abstract should contain the following information: introduction, main idea and purpose, methods and approaches, novelty, research results, conclusions. Size of the abstracts should be from 200 to 250 words.
- 6. The author's(s') surname and first name, information on academic degree and title, place of employment, position should be submitted in English in a separate document "Information about the author(s)".

- 7. Each article must be supplied with key words in Russian and English (up to 10 words or phrases).
- 8. At the end of each article there must be References. The list of references should contain at least 15-20 sources. References to the articles from journals or collected articles should necessarily indicate the pages on which the article is located (for example, Kovaleva T.Yu., Baleevskih V.G. Identification of the educational clusters in the regional economy: theory, methodology and research results (through the example of Perm Krai). *International Journal of Econometrics and Financial Management*, 2014, Vol. 2, no. 4, pp. 153–162.). When referring to a literary source in the text, its sequence number should be placed in square brackets (for example, [2], [2, 3]). If you specify the page(s), it should be done as follows: [2, p. 312]; [3, p. 312-320; 4, p. 10]. When listing electronic resources of remote access (from the Internet), the date of access to the document should be stated in parentheses after the Internet address (accessed 01.03.2009). In the text of the article there must be references to all the sources in the list, and vice versa.
- 9. In a cover letter the author should state that they consent to the terms and conditions of publication, that the given article has not been published previously, that they do not object to the article being reproduced in other academic and scholarly periodicals (including electronic) and also state the section in which the article is supposed to be published.

The author(s) must send a signed printed copy of the article, information about the author(s) and a cover letter confirming their consent to the terms and conditions of publication to the editorial office by e-mail: vestnik.psu@yandex.ru.

- 10. The article should be of a high academic level, characterized by scientific novelty (new theoretical, methodological approaches, new facts, hypotheses, new research results...). The relevance of the research issue should be justified. Since the language and style of the article are means of conveying depth and logic of its content, it should be written in a good literary language. Text should be logically coherent. All parts (paragraphs) of the article should have a close logical connection with each other. Concepts introduced in the article and expressed in terms should necessarily be defined in a correct and logically clear way.
- 11. In the event that the paper is accepted, the author must sign a license agreement and an acceptance certificate and send them to the editorial office.

Attention! In case of non-compliance with the submission requirements and formatting guidelines, the manuscript will not be considered.

All articles are peer reviewed by means of double-blind review system. Manuscripts will not be published and will not be returned if the article is rejected due to non-compliance with the themes, terms or formatting requirements, and in case there is a negative review.
